Call for National Experts

Preparation of National Analytical Documents on Violence against Women and Technology-Facilitated Violence

The Center for Support of Women (Kikinda, Serbia), in cooperation with the “Lara” Foundation (Bijeljina, Bosnia and Herzegovina) and Medica Kosova (Gjakove, Kosovo*), invites applications from qualified experts from the Western Balkans for the preparation of national analytical documents that will contribute to the development of a regional training curriculum on violence against women, with a particular focus on **technology-facilitated violence (TFV)**. This assignment is implemented within the project “**Learn, Connect, Act, Protect Yourself – Empowering Women’s Organizations and Networks in the Western Balkans to Combat Digital Violence against Women.**”

The project aims to strengthen the capacities of women’s organizations and networks across six Western Balkan countries to recognize, prevent and respond to violence against women, including technology-facilitated violence. The project is implemented within the regional programme “**EU for Gender Equality: Economic Empowerment of Women and Ending Violence against Women,**” funded by the **European Union** in cooperation with **UN Women and UNDP**.

Scope of the Assignment

Six national experts will be selected, one from each of the following countries:

- Bosnia and Herzegovina
- Serbia
- Montenegro
- North Macedonia
- Albania
- Kosovo*

Selected experts will prepare national analytical documents that will contribute to the development of a **regional training curriculum and training programme** addressing violence against women and technology-facilitated violence in the Western Balkans.
